 - b. 2023-09-02 A Resolution to Comply with the RCW 64.38.045 Annual Audit The RCW says that an annual audit may be waived if two-thirds of the members agree to it. The Board thinks it's prudent not to waive an audit for 2023.
 - c. 2023-09-03 A Resolution to Approve the 2022 Annual General Membership Meeting Minutes. The Minutes have been on the website since last year. They are reprinted in the Voter's Pamphlet. This is the last opportunity to make corrections or changes.
- 6. **Introduction of Candidates for the Board of Directors** (3 to 5 minutes each)
 - a. Kelly Burningham has lived in Clearwood for 9 years, loves it here. After 35 plus years working in property management managing HOAs and condos, he retired to Clearwood. He has now decided to start participating with whatever he can do. He has been "on other side of the desk", attending Board meetings as property manager, not board member. He is aware of the RCW's and how things work. Q from Alexa: Do you have any areas of special interest, such as finance, facilities, etc.? A from Kelly: He prefers to be member at large to begin with.
 - b. Alexa Burns Current board member for just over 3 years, filled out vacant position then ran for the Board and was selected to be Secretary. This has included some operational activities, which are now being passed to the General Manager. She will no longer be producing the newsletter and maintaining website a staff person is taking over. She is currently on the Finance Committee and Member Activities Committee and has been on the Elections Committee. We have come a long way: the Budget makes sense and is based on data, several major projects have been completed and others are under way.
